Below are the terms and conditions for the hire of Jump for Joy Moray's 2 metre x 2 metre Ball Pool. You will be emailed a copy of this document to review before deposit is paid, upon payment for deposit we will assume agreement of this document. If you do not agree with any information on this document, please contact us immediately and we will arrange the cancellation of your booking. On day of hire you will be issued with a personalised copy of this document to sign, which will be retained by Jump for Joy Moray for our records. After the booking you will be emailed a copy of the signed documents for your records. ***We kindly ask that the soft play is not scattered all over the venue when we return to collect. Please try to collect as many items/balls as you can and return into the soft play. This just makes the collection process lot faster.***

Jump For Joy Moray accept no responsibility for damage or injury whilst our equipment is under hire to you:

- Once the ball pool is set up by the hire company, the hirer is solely responsible for the safe operation of the ball pool, they must ensure that all possible steps are taken to avoid injury or damage to the equipment.
- The ball pool has a max hire age of 8 years old, no one over this age is permitted to use the ball pool.
- All soft play is to be supervised by someone over the age of 18 years old.
- Under no circumstance can food or drink be consumed in the ball pool, any food or drink stains or marks on the ball pool will result in a cleaning charge.
- Shoes, jewellery, keys, lighters, or sharp objects are strictly prohibited in the ball pool.
- No face paint is permitted on the ball pool, some face paint can stain the soft play. If face paint stains the ball pool, a cleaning charge or even replacement charge may be applied.
- Any damages that occur during the hire are the responsibility of the hirer listed above, any damages may be charged up to the value of replacing a whole new unit.
- Any missing items at time of collection will be subject to a charge of replacing the missing unit, the hirer listed above will be responsible for any charges. Any missing items from a set may be subject to a charge of replacing the full set of items.
- All units will be checked on delivery of any cleanliness issues, we will clean at location if units get dirty during set up. In signing the document, you agree that the units are clean and in good working order.
- Only employees of Jump for Joy Moray are authorised to collect the equipment, equipment shouldn't be handed over to anyone who is not a Jump for Joy Employee. If you have any concerns, please contact us immediately.
- The hirer listed above is solely responsible for any injury or damage that occurs whilst the equipment is in the care of the hirer. Always remember to be safe and have fun.
- All bookings can be cancelled or transferred up to 3 weeks before the booking without the loss of deposit, after 3 weeks the deposit will be retained but, in case of cancellation, you can transfer you booking to a different date within 6 months of the original hire date. Bookings may only be transferred once. Any transferred booking must be to the same cost or more.

### **BALL POOL RULES AND SAFETY GUIDELINES**

The below are rules of play and safety guidelines to ensure that you have an enjoyable and safe experience while hiring the ball pool. Please ensure that you have read the below carefully and fully. By signing the terms and conditions you are accepting liability for any damaged or missing items as well as any injuries that may occur. The hire company does not accept any responsibility for missing or damaged items or any injuries that may occur.

The hirer named in the above document must ensure the following:

- No overcrowding of the equipment, you should limit the number of children on the equipment based upon the size of the children using it. The hire company accepts no responsibility for any damage or injury.
- Avoid, where possible, having too many older children and younger children in the ball pool at the same time, this will help prevent accidental injury of a younger child. The hire company accepts no responsibility for any damage or injury.
- Under no circumstances should children jump into the ball pit from the side walling of the ball pit, or from any other platform/place from height. The hire company accepts no responsibility for any damage or injury.
- To avoid children tripping over side walls always help the children in and out of the ball pool. The hire company accepts no responsibility for any damage or injury.
- Do not walk or sit on the side walls of the ball pit. This is to prevent damage; the hire company accepts no responsibility for any damage or injury.
- Please note anyone with a medical condition or history of back and neck problems are strictly not permitted on the soft play, at any time.
- Under no circumstances are safety mats to be removed from the ball pool and no equipment is to be removed from the area.
- Please ensure socks are strictly worn for hygiene reasons. If someone accidentally enters with soft play area without socks, please make the collection driver aware. Extra cleaning must take place.
- Please note face paints are not permitted in the ball pool as this can stain the ball pool, if a child accidentally enters with face paint of, please wipe clean immediately. If ball pool is returned with face paint on it a cleaning or replacement charge may be chargeable to the hirer as named on this document.
- No food or drink is permitted in/on the ball pool at any time.
- No shoes are permitted in/on the ball pool at any time.
- No Jewellery or sharp objects are permitted in/on the ball pool at any time.
- No Lighters or flammable items are permitted on or near the ball pool.

All our soft play is designed and manufactured in Britain to British Standards and the above guideline must be followed to ensure safe and enjoyable fun at your event.
