If you do not agree with any information on this document, please contact us immediately and we will arrange the cancellation of your booking. On day of hire you will be issued with a personalised copy of this document to sign which will be retained by Jump for Joy Moray for our records, after the booking you will be emailed a copy of the signed documents for your records. **We kindly ask that the soft play is not scattered all over the venue when we return to collect. Please try to collect as many items/balls as you can and return into the soft play. This just makes the collection process lot faster.**

Jump For Joy Moray accept no responsibility for damage or injury whilst our equipment is under hire to you:

- Once the soft play equipment is set up by the hire company, the hirer listed above is solely responsible for the safe operation of the soft play structure, they must ensure that all possible steps are taken to avoid injury or damage to the equipment.
- The soft play structure has a max hire age of 8 years old, no one over this age is permitted to use the soft play.
- All soft play is to supervise by someone over the age of 18 years old.
- Under no circumstance can food or drink be consumed on the soft play, any food or drink stains or marks on the soft play will result in a cleaning charge.
- Shoes, jewellery, keys, lighters, or sharp objects are strictly prohibited on the soft play.
- No face paint is permitted on the soft play, some face paint can stain the soft play. If face paint stains the soft play a cleaning charge or even replacement charge will be applied
- Any damages occurred during the hire is the responsibility of the hirer listed above, any damages may be charged up to the value of replacing a whole new unit.
- Any missing items at time of collection will be subject to a charge of replacing the missing unit, the hirer listed above will be responsible for any charges. Any missing items from a set will be subject to a charge of replacing the full set of items.
- All units will be checked on delivery of any cleanliness issue, we will clean at location if units get dirty during set up. in signing the document, you agree that the units are clean and in good working order.
- Only employees of Jump for Joy Moray are authorised to collect the equipment, equipment shouldn't be handed over to anyone who is not a Jump for Joy Employee. If you have any concerns, please contact us straight away.
- The hirer listed above are solely responsible for any injury or damage that occurs whilst the equipment is in the care of the hirer. Always remember to be safe and have fun.
- All bookings can be cancelled or transferred up to 3 weeks before the booking without the loss of deposit after 3 weeks the deposit will be retained but you can transfer you booking to a different date within 6 months of the original hire date. Booking may only be transferred once. Any transferred booking must be to the same cost or more.

SOFT PLAY STRUCTURE RULES AND SAFETY GUIDELINES

The below are rules of play and safety guidelines to ensure that you have an enjoyable and safe experience while hiring the soft play. Please ensure that you have read the below carefully and fully. By signing the terms and conditions you are accepting liability for any damaged or missing items as well as any injuries that may occur. The hire company does not accept any responsibility for missing or damaged items or any injuries that may occur.

The hirer named in the above document must ensure the following:

- No overcrowding of the equipment, you should limit the number of children on the equipment based upon the size of the children using it. The hire company accepts no responsibility for any damage or injury.
- Avoid where possible have too many older children and younger children on the soft play at the same time, this will help prevent accidentally injury of a younger child. The hire company accepts no responsibility for any damage or injury.
- Under no circumstances should any adult or child climb the sides of the soft play, stand on top, hang from the soft play, or climb the slide. If any of this is witnessed by the hire company your hire will cease with immediate effect, full payment the full hire must still be paid. – no exceptions.
- Ensure that only one child at a time is going down the slide and ensure the slide is clear from children and obstructions.
- Ensure side of the slide are always attached, no child should go down the slide whilst the sides of the slides are off.
- Avoid children climbing over younger children whilst going up log ramp by always supervising younger children whilst on the soft play.
- Never use the rockers outside of the soft play area, the floor mats are made up of 60mm thick, soft play foam and will help prevent serious injury if you were to fall from the rockers. The hire company accepts no responsibility for any damage or injury.
- Please note anyone with a medical condition or a history of back and neck problems are strictly not permitted on the soft play, at any time.
- Under no circumstances are safety mats to be removed from the soft play area and no equipment is to be removed from the area.
- Please ensure socks are strictly worn for hygiene reasons. If someone accidentally enters with soft play area without socks, please make the collection driver aware. Extra cleaning must take place.
- Please note face paints are not permitted on the soft play as this can stain the soft play, if a child accidentally enters with face paint on, please wipe clean immediately. If soft play is returned with face paint on it a cleaning or replacement charge will be chargeable to the hirer as named on this document.
- The hirer detailed above must ensure that access is good with no stairs or tight turns. Doors must have a minimum opening size of 750mm and a height of at least 1880mm and that there is an appropriately sized space for the soft play to sit.
- No food or drink is permitted on the soft play at any point.
- No shoes are permitted on the soft play at any point.
- No Jewellery or sharp objects are permitted on the soft play at any point.
- No Lighters or flammable items are permitted on or near the soft play.
- Children are not permitted to help set up or dismantle the soft play.
- **During set up and collection the hirer, large heavy items will be in motion the hirer detailed above must ensure that any children they are responsible for are out of the way whilst we are moving items and not climbing on the soft play as we are setting up or dismantling the structure. If children are in the way we will stop setting up or packing away items, no payment reductions will be given if we are not set up in time for your party start time and if we have not left the venue within your time slot booked, we will not accept any responsibility for any charges you may face. If we cannot safely set the soft play up due to children running around or climbing on the soft play, we will cancel the booking there and then and you will still have to pay the full booking fee. The hire company listed above does not accept the responsibility for any damages or injuries that occur during set up or collection.**

All our soft play is designed and manufactured in Britain to the British Standards and the above guideline must be followed to all ensure safe and enjoyable fun at your event.
